

# Conditions of Participation

These Conditions of Participation regulate participation in the competition entitled „Looking for a Catalogue“ run by „cycle union GmbH, An der Schmiede 4, 26135 Oldenburg“, and are exclusively subject to German law.

## **Period of participation**

It is possible to participate in the competition from November 2017 to 30 June 2018. cycle union GmbH reserves the right to alter this period if important reasons require it. cycle union GmbH will communicate this in the same way as the competition itself was communicated.

## **What can be won?**

100 x Topeak „Hummer2“ multi-tools, 50 x „Trailon“ bicycle helmets [black] by KED and 25 x „Bordo“ bicycle locks by ABUS will be given away across all the participants.

## **Who can participate?**

Natural persons over the age of 18 are eligible to participate. Each person is only allowed to participate once.

Employees of cycle union GmbH, Kreidler Europe Motor GmbH, Prophete GmbH u. Co. KG and their relatives are excluded from participating in the competition.

## **How can one participate?**

As a minimum, participants must provide their email address, name and address so that we can notify them if they win or do not win, and so that we can send them their prize. Personal information will not be disclosed to third parties. Each participant will automatically participate in all the draws that are yet to take place after the participation date.

## **What does one need to consider?**

The cash payment of prizes, or the exchange of prizes, is excluded. Each participant can only win one prize. Individuals participating multiple times will be excluded from the game: each participant can only win once.

## **Early termination, exclusion**

cycle union GmbH has the right to cancel or terminate the competition at any time without prior notice. cycle union GmbH may make use of this, for example, if significant malfunctions, considerable disruptions, forgeries, viruses or similar significant damage occur which adversely affect the administration, security, fairness, integrity or the operation of the competition.

cycle union GmbH reserves the right to exclude participants who violate these Conditions of Participation. In particular, this applies if participants engage in manipulation, use other dishonest aids, or enter false personal information. In these cases, prizes can even be withdrawn and reclaimed retrospectively.

## **Data protection**

Entering data is voluntary, but it is necessary for participation in the competition. Data not required in order to participate is marked separately. Personal data will be used for the issuance of notifications relating to the competition. We give our assurances that personal data will not be passed on to third parties.
